Foster Contract

This Foster Contract ("Contract") is made effective on the date indicated below, by and between K9 Freekz Rescue, a Nebraska based non-profit rescue and (the "Foster") as indicated in the name field above. K9 Freekz and Foster are individually a "Party" and collectively the "Parties" to this Contract. "Foster" has agreed to foster and care for the animal described above (the "Pet"), and K9 Freekz Rescue has agreed to release such Pet to Foster, subject to and in accordance with the following terms and conditions:

Care of Pet

_____ I, The Foster, hereby clearly agrees to, and shall strictly comply with, the following terms, conditions, and obligations relating to the care of the Pet:

- FOSTER SHALL ACCEPT AND CONSIDER THE PET AS A HOUSEHOLD COMPANION, NOT AS AN OUTSIDE PET, AND WILL PROVIDE THE PET WITH A SAFE ENVIRONMENT, HUMANE TREATMENT, AND PROVIDE PROPER FOOD DAILY, FRESH WATER DAILY, SHELTER, AND EXERCISE.
- FOSTER SHALL NOT ABUSE OR NEGLECT THE PET AND UNDER NO CIRCUMSTANCES PHYSICALLY PUNISH THE PET. THE PET WILL NOT BE CHAINED UNSUPERVISED AT ANY TIME. THE ABOVE DOG MUST BE ACCOMPANIED BY THE ABOVE FOSTER WHEN OFF THE ABOVE PROPERTY.
- PET SHALL BE ALLOWED TO SLEEP INDOORS AND PROTECTED FROM THE ELEMENTS OR ADVERSE CONDITIONS. PET SHALL NOT BE HOUSED OR KEPT OUTSIDE UNLESS OKAYED BY THE RESCUE DIRECTORS. THE PET SHALL NOT BE ALLOWED TO ROAM FREE OR UNSUPERVISED OUTSIDE.
- FOSTER WILL NOT PERMIT THE PET TO RUN AT LARGE OR BECOME A PUBLIC NUISANCE.

- IN THE EVENT THAT THE PET BECOMES LOST, FOSTER SHALL MAKE IMMEDIATE AND SERIOUS EFFORTS TO LOCATE AND CLAIM THE PET AND CONTACT K9 FREEKZ RESCUE IMMEDIATELY.
- FOSTER WILL RETRIEVE THE PET FROM ANY POUND OR SHELTER IF NOTIFIED THE PET IS BEING HELD AT ANY LOCATION.
- FOSTER SHALL NOT GIVE UP OR SELL THE PET TO ANOTHER PERSON, RELATIVE, FRIEND, OR ANY OTHER INDIVIDUAL, OR ANY RESCUE GROUP, HUMANE SOCIETY/ASSOCIATION, SHELTER, OR ADOPTION CENTER UNLESS PRE-APPROVED BY K9 FREEKZ RESCUE.
- FOSTER SHALL NOT, UNDER ANY CIRCUMSTANCE, GIVE UP OR SELL THE PET FOR ANY MEDICAL OR EXPERIMENTAL LABORATORY OR ANY ORGANIZATION.
- FOSTER SHALL NOT ALTER THE PET’S APPEARANCE IN ANY WAY, SHAPE OR FORM (IE: CROPPING, DOCKING).
- FOSTER PERMITS K9 FREEKZ RESCUE TO VISIT AT ANY TIME TO CHECK ON THE WELL BEING OF THE PET.
- FOSTER CONSENTS TO THE EXAMINATION OF THE PET BY K9 FREEKZ RESCUE AT ANY TIME AND ACKNOWLEDGES THAT K9 FREEKZ HAS THE RIGHT TO RECLAIM THIS PET, IN K9 FREEKZ SOLE AND ABSOLUTE DISCRETION, AT ANY TIME FOR FAILURE TO COMPLY WITH THE TERMS OF THIS CONTRACT OR FOR ANY MISREPRESENTATION OF FACT MADE ON THE ADOPTION APPLICATION OR IN THIS CONTRACT.
- FOSTER REPRESENTS AND WARRANTS THAT ALL INFORMATION PROVIDED TO K9 FREEKZ RESCUE IN THIS CONTRACT IS CORRECT, COMPLETE, AND ACCURATE.
- THE FOSTER HOME UNDERSTANDS AND AGREES TO ADHERE TO ALL RELEVANT ZONING AND ANIMAL CONTROL CODES AND ORDINANCES, WHETHER LOCAL, COUNTY, OR STATE.

Appointments

_____ Foster shall coordinate and schedule all medical, veterinary, and training appointments for the Pet AND notify the rescue director(s).

- Foster shall be responsible for transporting the Pet to and from all such appointments.
- If Pet is not spayed or neutered as of the Foster Date, Foster must arrange to have the Pet spayed or neutered at one of K9 FREEKZ approved veterinary clinics when/if the pet becomes of age.
- Foster shall immediately notify THE RESCUE in the event of the Pet’s injury, illness, or death during the foster care period.
- The Foster understands that if he/she takes the Pet to an unauthorized veterinarian the Foster may be liable for expenses.
- Foster is responsible for keeping ALL the dog(s) in their care (foster and personal) up to date on all vaccinations including, but not limited to. . .

Food & Supplies

_____ K9 FREEKZ RESCUE will provide Foster with food and or supplies necessary for the care of the Pet during the term of the foster care; provided, however, Foster shall notify a RESCUE DIRECTOR in advance regarding any expected supplies or food needed for the care of the dog.

- If Foster voluntarily chooses to purchase food, supplies, or other items relating to the care of the Pet, with his or her own money, Foster should save the receipt as these expenses are tax deductible.
- Fosters will be reimbursed for authorized purchases.
 - Foster must submit receipt to K9 FREEKZ RESCUE via text message or email within 30 days of purchase for reimbursement.
- Purchases made voluntarily, and not approved by RESCUE DIRECTOR, by Foster are not reimbursed by K9 FREEKZ RESCUE.

Marketing and Promotion

_____ K9 FREEKZ RESCUE advertises our dogs available for adoption through events, social media, our website, and online adoption sites.

- Foster is responsible and expected to assist in marketing the Pet for permanent adoption including but not limited to word of mouth, bringing the Pet to adoption events, and/or by providing photos and a good description of Pet for K9 FREEKZ RESCUE'S marketing materials.
- I UNDERSTAND that any potential adopter MUST be screened, interviewed, and approved by an authorized RDR representative. I understand that my input will be appreciated and a part of the process, and that the final decision to place or not to place my foster or any particular dog with a potential adopter will be made by an authorized K9 Freekz Director.
- I AGREE to let K9 FREEKZ know if prospective adopters may contact me directly by phone or email, and to send copies of any email inquiries to a K9 FREEKZ representative.

Foster Period

_____ Foster understands and agrees that it is not possible to accurately estimate the amount of time required to adopt a pet, and that the foster period could take weeks, months even year(s).

- Notwithstanding the foregoing, Foster agrees and is committed to foster the Pet for as long as is necessary.
- If Foster can no longer care for the Pet, Foster shall notify K9 FREEKZ RESCUE and make every effort to find a suitable foster or adoptive home for the Pet. However, the Foster understands that it may take time to find the Pet a sufficient replacement foster or permanent adopter for its needs.
- Foster understands that during the foster period, K9 FREEKZ has ownership of the dog and that K9 FREEKZ may recover the pet from Foster at any time during the foster period, in K9 FREEKZ sole and absolute discretion.

Option to Adopt

_____ If Foster decides to permanently adopt the Pet, Foster shall notify K9 FREEKZ RESCUE immediately and upon approval, shall follow established adoption procedures including signing an Adoption Contract and paying the Pet's adoption fee.

- If Foster finds a permanent/adoptive home for the Pet, Foster shall notify K9 FREEKZ RESCUE and upon approval, shall follow established adoption procedures.

Assumption of Risk; Release; Indemnity

_____ Foster acknowledges that, due to the unpredictable nature of animals, there are certain inherent risks and dangers associated with the care and custody of a Pet, including but not limited to risks of injury to persons or property.

- Foster voluntarily agrees to assume full responsibility for all such risks and waives and releases, K9 FREEKZ RESCUE and its owners, directors, volunteers, employees, and representatives from any and all claims, losses, liabilities, injury, or damages of any kind or nature whatsoever arising from or relating to the foster and care of the Pet, including but not limited to claims of bodily injury or property damage sustained by Foster, Pet or others.
- Foster also agrees to be solely responsible for any actions of the Pet and agrees to indemnify and hold harmless K9 FREEKZ RESCUE and its owners, volunteers, employees, and representatives from any liabilities, injuries or losses caused by the Pet or any causes of actions, claims, suits or demands that arise from such injury, damages, or losses.

No Warranty

_____ Foster acknowledges, understands, and agrees that K9 FREEKZ RESCUE makes no guarantees, promises, representations, or warranties whatsoever, expressed or implied, written or unwritten, regarding the Pet's disposition, temperament, and/or current or future health and personality.

- The Foster agrees to take the Pet as is and with any and all faults.

Entire Agreement; Severability; Amendments; Waiver

_____ This Contract constitutes the entire agreement between the Parties hereto concerning the matters covered herein and supersedes all prior agreements and/or understandings, between the Parties, whether written or oral, concerning the matters covered herein; and there are no understandings, agreements, representations, or warranties, expressed or implied, which are not specified in writing and signed by the Parties hereto.

- In the event that any of the terms of this Contract are or become illegal or unenforceable, such terms shall be null and void and shall be deemed deleted from this Contract and all the remaining terms of this Contract shall remain in full force and effect.
- The Parties may only amend this Contract in writing signed by the Parties.
- No waiver of any provision of this Contract, nor consent to any departure by either Party therefrom, shall in any event be effective unless the same shall be in writing and signed by the Party to be charged with the waiver or consent, and then such waiver or consent shall be effective only in the specific instance and for the specific purpose for which given.

Cats & Dogs Coexisting

_____ I/We understand that even if this animal has been housed with cats in its previous environment that K9 FREEKZ RESCUE cannot guarantee the behavior with a new cat(s) will be the same.

- I agree to use caution when introducing a new dog to existing cats in the household and do introductions slowly over a period of a few weeks, keeping the dog on leash if necessary.
- If I need assistance, I will contact a K9 FREEKZ RESCUE representative for help.

Governing Law; Venue; Disputes

_____ The enforcement and interpretation of this Contract shall be governed by the laws of the State of Nebraska. Any and all disputes arising under or related to this Contract which cannot be resolved through discussions between the Parties shall be submitted to binding arbitration, by a single mediator through the law, attorney or any similar arbitration provider mutually agreed upon by the Parties

Protocol With Children

_____ I/We understand that the following protocol should be followed regarding children in the house

- I agree to NOT leave a child unattended with any dog.
- I agree to NOT leave bones and/or toys around the house unsupervised when children are present and be cautious and observant when children are eating, and the dog is in the room.
- I understand the dog should be in a crate or separate room while the is dog eating or sleeping to prevent accidents.
- I agree that children under the age of 13 will not walk the dog unattended unless supervised by an adult.
- I understand that whenever a child is in the house with a dog, the child is at risk of being accidentally knocked over, scratched, or bitten, etc.
- I agree that should I have ANY concerns or feel uncomfortable with a situation between the dog and a child, I will contact a K9 FREEKZ RESCUE Representative.
 - We will either take the dog out of your home or have a trainer get in touch and/or meet with you, depending on the severity of the situation.

Multiple Dog Households

_____ I/We understand that the following protocol should be followed when bringing additional dogs into the house.

- I agree to NOT leave multiple dogs at home in the same room unattended.
- I agree to NOT feed the dogs in the same room and NOT to leave toys/treats unattended around the house.
- I agree to contact a K9 FREEKZ RESCUE if I need assistance with dog to dog introductions.
- I agree to introduce the dog slowly to new environments while he/she is decompressing.
- I agree to allow the dog to have decompression time, separate from other dogs, so it can acclimate to its new environment.
- I agree to foster for one rescue at a time, for example, if I am fostering for K9 Freekz Rescue, I agree to NOT foster or bring in a dog from another rescue until the K9 Freekz foster dog has been adopted.

Home & Environment

_____ I/We understand that the following protocol should be followed when bringing additional dogs into the house.

- I agree to make sure all unsafe items are not left open or accessible for a dog to harm itself (poisonous foods, sharp objects, etc.)
- I agree to watch the foster dog at all times while outdoors, even when in an enclosed yard, to ensure they are safe.
- I agree to have a collar, harness, leash on my foster at all times to ensure they are easily accessibly if something were to happen.
- I agree to check all doors, locks, etc. to ensure dogs cannot escape or become a danger to themself or others.
